TeliaSonera donates over 300.000 US Dollars to SSE Riga



At a ceremony on Thursday 29 January in Riga, Kenneth Karlberg formally gave a donation of USD 330,000 to the rector of the school, Anders Paalzow. The donation will finance a professorship for three years. At the same time, the TeliaSonera Institute is being formed at the school to serve as a type of think tank. The school will also arrange a number of TeliaSonera Business Days.



Before the event, Anders Paalzow and Kenneth Karlberg took part in a press conference, with over 20 journalists participating.

Anders Paalzow said: "TeliaSonera's donation is very important for our school and it is a great event for the Latvian academic society. The donation will allow Latvia to take up serious activities in order to gain a competitive advantage in the support and promotion of entrepreneurship. I consider it to be a big investment in the establishment and promotion of entrepreneurship, which is a major prerequisite for the economic growth of this region."



Kenneth Karlberg also emphasized the importance of promoting the region's development, and said that TeliaSonera has a longterm commitment to Latvian society.

TeliaSonera Representative Kenneth Karlberg said: "One of the most essential reasons is the fact that this company perceives Latvia as an important country in the Baltic Sea region. Our interests involve support and promotion of business development as we all benefit from that. We consider that each country has its own unique values, which create unique business opportunities providing benefits to the whole region. Especially important are students, as they provide continuous links between the national traditions and the future of the respective country."

The lab will also play an active role in national innovation by linking education, public R&D, and the private sector, and should play an active role in promoting entrepreneurship culture in the Baltic States.

Ever since the Anders Wall foundation was formed in 1981, Scholarships have been awarded to successful students with achievements in entrepreneurship. These students are from Sweden, Finland, and since 1996 also have come from the Baltic through SSE

Riga. So far, Scholarships in the fields of science, international studies, agriculture innovation, and classical music have been awarded. The ceremony took place in the Swedish Royal Music Academy in Stockholm, in the presence of the Royal Princess. Mrs Christina Magnusson, and the cream of the Swedish culture and business community. This year, Latvian SSE Riga student Kaspars Vitols was awarded for his contribution of the development of a new successful business idea (B B) "Business meets Business". The Water Framework Seminar at SSE, on the 29th of January 2004

The Baltic Water Fund – a project initiated and led by SSE Riga and financed by the Swedish Baltic Billion Program – aims at creating a new instrument for the Baltic capital markets for the financing of infrastructure investments in the Baltic States. The Fund will be quoted on the local stock exchanges, and will make investments and lease installations to municipalities.

As part of the project, the Fund was one of the organizers of the Water Framework Seminar.

Two years ago, the negotiations on the EU Water Framework Directive came to a successful Directive provides conclusion. The for the sustainable and integrated management of river basins including binding objectives, clear deadlines, and a comprehensive programme of measures based on scientific, technical and economic analyses, including public information and consultation. Whereas the political European decision-making process ended, it became soon clear that the successful implementation of the Directive will be, at the least, equally as challenging and ambitious for all countries, institutions and stakeholders involved. Hence, a strategic document establishing a Common Implementation Strategy (CIS) for the Water Framework Directive (WFD) was developed and finally agreed under the Swedish Presidency in a meeting held in Sweden on the 2nd to 4th of May, 2001.

The seminar was intended to provide responsible people in state, municipal and other organisations to deal with water management in Latvia, with an overview of knowledge of the European Water Framework Directive. The aim of the seminar was to familiarise participants with the River Basin Management in particular that underlies the directive, in order to match the requirements, bring people together that are working with different water issues. and. present and propose ways to finance development and investments in infrastructure. 120 persons participated in the seminar that started at 9.00 and was ended at 16.00, after a full day the impression was that the participants were more than satisfied with the event. SSE carried out their part of the work; the translation, technical assistance, and catering were brilliant in their performance. It's also very inspiring to be in the SSE environment, as that brought energy to the event.

Days of Opportunity 2004

SE Riga is recognized as the best higher education institution for auditors and financiers in Latvia. Since its foundation, 450 high level specialists have graduated from the school. Pro-rector Diana Pauna states that competitiveness among universities has increased, and it encourages the school to raise its standards.

The SSE Riga Opportunity Days helps students to find internship places for summer practice, as well as to investigate their future workplaces. A credit analyst for Vereinsbank, Alise Ilzina, who is an SSE Riga graduate, says that in her department four of eight employees are from the school. She says that SSE Riga does not specifically teach how to work in a bank, but it gives knowledge on how to work intensively and to acquire needed skills for the employment.

Lately competitiveness in the labour market in Latvia has increased considerably, and SSE Riga graduates are ready to fight for the best places. Many future graduates think about careers in the marketing field. They know how to find, process and analyze information, how to work in groups and in an

international environment. At present 42% of year 2003 graduates work in auditing companies. SSE Riga graduate Arnis Malbergs, a Unibanka financial market analyst, says that the banking environment is very conservative, and it may seem slow for some SSE Riga graduates who enjoy the fast track in career development.

Lately students have become more interested in the tourism business and the IT field. Those are currently the developing fields of industry. SSE Riga acknowledges that there is tough competition between different educational institutions, and therefore has introduced a student mobility program, and improved cooperation with potential employers.

In recent years, more and more graduates are becoming interested in public sector careers.

This year, 27 companies participated. The previous participants have all stayed and new ones have joined.
